
All registered candidates are advised to visit the official website <https://exams.nta.nic.in/cuet-pg/>, and verify their particulars in their respective Online Application Forms. If required, they may make corrections in the permitted fields only within the above period.

*With reference to the public notice dated December 19, 2025, candidates who submitted their application forms and paid the application fee on or before December 19, 2025, are being given an opportunity to update their additional examination city preferences in the correction window.*

No corrections will be accepted after 30 January 2026 (11:50 P.M.) under any circumstances. The additional fee (if applicable) shall be paid by the candidate concerned through Credit/Debit Card, Net Banking, or UPI only.

This facility is extended only once to avoid any hardship to the candidates. Therefore, candidates are advised to make corrections carefully, as no further opportunity for correction will be provided.
